Code Of Criminal Procedure 1898 (CrPC) About Code Of Criminal Procedure 1898 (CrPC) In 1898 Code of Criminal Procedure was introduced into India. The Code of Criminal Procedure Rules is a comprehensive body of rules governing criminal law. It has six parts. First, part of rules refer to the Rules of Court. Second part of the Rules has criminal procedure code of 1898. Third part of the Rules are related to procedure and evidence. Fourth part is related to pleading in the criminal case. Fifth Part is about judicial and other proceedings. These rules also govern the determination of the person who shall try the case. Eighth part is related to detention and reporting of offenders. Ninth part of the Rules give the procedure of arrest. Tenth part of the Rules are related to bail in criminal cases. Code of Criminal Procedure 1898 is a statutory law enacted in 1898. Code of Criminal Procedure 1898 was enacted to unify the procedure of trial in criminal cases and came into force on 1-8-1948. Code of Criminal Procedure provides for the method of investigation, trial, appeals and punishment of offenders. Code of Criminal Procedure 1898 laid down the procedure of trial in criminal cases as well as the method of punishment. Code of Criminal Procedure was amended on several occasions. In 1898, Amendments Act, II, was enacted. In 1973, Criminal Procedure Code was amended and made into a separate Act. Amendments in 1974 and 1998, brought major changes in Criminal Procedure Code 1898. Code of Criminal Procedure has six chapters. Chapter 1 deals with Preliminary Investigation. Chapter 2 deals with the Summary Offence. Chapter 3 deals with indictable offence. Chapter 4 deals with Classes of offences. Chapter 5 deals with offences in respect of Indians in special tribunals. Chapter 6 deals with offences in respect of Indians not in special tribunals. This Chapter deals with offences in respect of non-Indian. F. No-one is to be convicted on the mere uncorroborated evidence of the oral testimony of a witness. G. In the trial of a person accused of a capital offence, he must not be convicted
